Aprašymas: The contracting authority has chosen to take care of climate and environmental considerations through concrete and binding requirements set in the requirement specification, rather than weighting climate and environment as the award criterion by a minimum of 30%. The choice is made in accordance with the Public Procurement Act § 5b, based on an assessment that the set minimum requirements provide better and more predictable climate and environmental effect throughout the contract period than evaluation of tenders based on relative environmental criteria in the tender phase. The tenderer is required to carry out all transport connected to the assignments emission free of charge in this procurement. This is a clear and ambitious main measure with documented significance for reducing greenhouse gas emissions. Furthermore, the requirements are directed directly to the procurement's most important environmental impact on electro material and the execution of the assignments. Particular emphasis has been put on: * Lifetime extension and re-use as a main rule for existing electrical material, equipment and fixed installations. * Re-use through disassembly, reassembly and retrofitting where it is technically and functionally justifiable. * Use of halogen free systems and the limitation of PVC based products, * Prioritising products with recycled or fossil free plastic when available * Documented environmental performance through third-party verified environmental documentation (EPD) where available in the market. * Waste reduction, material recovery and use of established recycling and take-back schemes for products and packaging. The contracting authority considers that these requirements to a greater degree ensure actual goal achievement and equal treatment of tenderers than an award criteria for climate and the environment. The requirements are based on available systems in the market, at the same time that they allow for further development in the contract period.
