The ice halls and ice surfaces are mainly rented out to departments and entities in Oslo municipality. The systems in operation will vary throughout the season and year. Oslobygg KF shall enter into a framework agreement with one tenderer for service and maintenance of cooling and heat pump installations; including consultancy related to these. The contracting authority's portfolio in the area includes ice installations of varying degrees and sizes as well as some other installations. . The portfolio consists of i.a. co2, freon and amoniak installations. The framework agreement shall cover Oslobygg KF's total need for Kulde- og Varme pumpetechnical services in a contract period of four years.

Aprašymas: In this procurement, the environment is not weighted as an award criteria by 30%. The contracting authority has chosen to have strict minimum requirements for the environment that, according to the contracting authority's assessment, will have a better environmental effect than setting up an environment as an award criteria, see the Procurement Act §5, letter b). In this competition, it is a requirement that the tenderer commits to only use vehicles that are either zero emission vehicles (100% battery electric or hydrogen) or biogas vehicles that as a minimum fulfil Euro class 6/VI in the execution of the contract (last transport stretch/cargo mile). In addition it is a requirement that the tenderer undertakes to comply with a number of environmental requirements, which are in the standard requirement specifications for Oslo municipality (SKOK). By setting such minimum requirements, it is ensured better climate and environmental effect than by setting up award criteria connected to the environment. This is because, even with a minimum of 30 percent weighting of the environment, the price risks being decisive in the competition, and that one thus ends up without the minimum requirements that are now set for the environment.
