Pagrindiniai procedūros ypatumai: Follo Ren IKS invites tenderers to an open tender contest for the hire of two new or newer used (not older than 2,025 models, maximum 200 operational hours) wheeled loaders (operational leasing). The machines shall be ready certified and shall be operated at our recycling stations, where they shall mainly move the hook containers. Other assignments include loading, snow clearing and various handling. The hire period is 5 years (60 months) from the delivery date. Annual operating time per machine: approx. 800 hours. The offered hire price for the vehicle shall include a driving time for the entire hire period of 5 years. The machines shall be delivered by week 42, 2026 (mid-October).
