Procedūras galvenās iezīmes: The contract's total value for all sub-contracts is estimated to NOK 14,536,212,000 excluding VAT over the course of four years. Increased need for transport under some sub-contracts for patient journeys may occur during the contract period. This can, for example, be due to changed patient needs, including patients who require more frequent transport to and from hospitals. Such conditions are deemed to lead to an increase in the total transport need of approx. 20 percent. The maximum extent of the procurement is NOK 17,443,500,000 excluding VAT.
