Documentation requirements: Norwegian companies: Company Registration Certificate

Foreign tenderers: Documentation of registration in a company register, trade register or equivalent register in the country where the business is established. Documentation can be presented in Norwegian, Swedish, Danish or English.

Atlases kritērija apraksts: Economic and financial capacity. This is normally seen as fulfilled if the tenderer has a credit rating equivalent to a minimum of creditworthy. Documentation requirements: Documentation of the tenderer's economic and financial capacity, for example, a credit rating from a certified credit rating institution (not older than 1 year), based on the last known accounting figures, revised annual accounts or other equivalent documentation. The contracting authority reserves the right to obtain supplementary financial information.

Apraksts: In this procurement there will be neither requirements nor award criterium for climate and environment, as the procurement has a climate footprint and an environmental impact that is immaterial, cf. the Utilities Regulations § 7-9 (5). The nature of the procurement in this case is the procurement of an electronic tool for carrying out calculations in the electricity network. Furthermore, the procurement involves maintenance and further development of such a tool, as well as operation and use of the tool. The work on maintenance and further development of the tool can be compared with a consultancy service without particular travel activities and is therefore considered to have immaterial climate footprint and environmental impact. However, if sub-supplier chains take into consideration, we can see that possible climate footprint and environmental impact may arise for the operation of the data centres on which the tool may be coughed. The supplier's influence over this energy consumption and the possible environmental impact is, however, very limited and it is aimless for the contracting authority to emphasise or set requirements in the requirement specifications for the environment in this procurement. Based on this, the procurement is, in its nature, to have immaterial climate footprint and environmental impact, and therefore falls under the exception rule in FF § 7-9 (5).
