Konsesjonskontraktforskriften - Halden municipality invites tenderers to apply for a licence for assistance hours in the scheme for user-controlled personal assistance for users in the municipality. BPA is pursuant to the Act on Patient and User Rights (The Patient and User

Rights Act) § 2-1d and the Act on municipal health and care services (the Health and Care Services Act) § 3-8, cf. § 3-2 first section no.6 letter b.

Konsesjonskontraktforskriften - Halden municipality's procurement 2026-103706 (service concession for user managed personal assistant) has the initial tender deadline 1 April 2026. However, at a municipal council meeting on 26 March it became clear that the municipal council will handle an interpellation regarding the procurement at the next municipal council meeting, which will be held on 16 April.
