The agreement shall cover the need for schools, nurseries, institutions and administrative units, as well as some private households where the municipality is responsible for the procurement of the goods. Private households means, for example, residences under the auspices of the refugee service and the municipality's residences/sheltered accommodations. Other units can also order as needed.
