Procedūras galvenās iezīmes: Trondheim municipality is in a good process of digitising large parts of the municipality. New flexible systems shall be developed that can easily be adapted to the current and future strategic objectives and work processes. The municipality would like to hold a competition that embraces the entire digitalisation area and not to divide the assignment into sub-areas. This will give several tenderers the possibility to submit tender offers.
