NESAs is establishing a joint consortium with main participants; Post- och telestyrelsen, Sweden and Elering AS, Estonia. Other participants are Cinia Oy, Affärsverket Svenska Kraftnät, Klimaministerium and Justiits- ja Digiministerium. The philosophy of the system and its performance is to purchase a storable and modular equipment and system which shall be located and stored in Finland and ready to be installed onboard an offshore construction or a support vessel on a Finnish shipyard or harbor facility in quick timeline. This is a negotiation procedure and in the first stage, the bidders selected for the first call for tenders round are selected.
