The framework agreement shall cover the contracting authority's ongoing need for wearing steel for, among other things: CutPloger Snow cutters, the framework agreement includes the delivery of wearing steel of the Küper Combination or equivalent and various wearing steel in both overcoats and dental executions, as well as toothed wearing steel with hard metal posts. Tenders can be submitted for parts of the assignment; Sub-contract 1: Various wearing steel. Sub-contract 2: Küper Combi or equivalent. Tenderers are invited to submit tenders for one or both lots. There are no limitations on how many sub-contracts one tenderer can be awarded; a tenderer can, therefore, be awarded both sub-contracts.
