Other documentation of equivalent environmental management measures will be accepted on the terms in the procurement regulations § 16-7 third paragraph.

Other documentation of equivalent quality assurance measures will be accepted on the terms in the procurement regulations § 16-7 third paragraph.

Documentation requirements: Description of up to three relevant assignments that have been carried out or are ongoing and where all or significant parts of the assignment were carried out during the last three years. The description shall state: * the contracting authority, * contract period, * the assignment's nature and extent, * stand-by and response time requirements, * the tenderer's role and responsibility, and * name and contact information of a reference person at the contracting authority. The contracting authority reserves the right to contact the provided references in order to verify the information.

Atlases kritērija apraksts: Tenderers shall have sufficient organisational and technical capacity to fulfil the contract's requirements for stand-by, response time and security of delivery.

Documentation requirements: Brief description of the tenderer's organisation and available personnel and machine resources for implementation of the contract, including organisation of contingency, available personnel and machine resources, capacity to maintain contractual deliveries in periods of frequent, long-lasting or extensive snowfalls, back-up capacity in connection with illness and machine breakdown, as well as planned use of sub-suppliers. If a tenderer will use other companies' capacity to fulfil the qualification requirement, the tenderer shall document that it will be able to use the necessary resources.
