The works requirements for the above sections will encompass all works necessary to complete the greenway including, design, PSDP Services, PSCS Services, environmental management, earthworks, drainage, pavement, fencing, landscaping, signage, slope stabilization, retaining wall construction, rehabilitation of existing structures, construction of new structures, road realignment, traffic management and all other services necessary to complete the works. The Design and Build Section contains a number of tunnels of historical and cultural significance.
