Elementi prinċipali tal-proċedura: The aim of the procurement is to be able to offer free user choice to users of home care services so that they themselves can choose between public or private service provision. Malvik municipal council decided to introduce free user choice in 2025 for home care and home nursing during April 2026. The municipality can take care of employer responsibility itself or enter into agreement with other public or private actors for offering home care and including taking care of employer responsibility. This competition is for the Home Help part of the free user choice. The scheme concerns users of home help in Malvik municipality who live in their own home. The scheme does not include users who live in residences where there is fixed staffing. Users of the service who do not wish to use free user choices or who do not make an active choice, are awarded assistance from the municipal service. The tenderer can offer additional services to the user. Additional services are services beyond what the user has received individual decisions on from the municipality. It will be possible for users on their own initiative to order additional services from the private service provider who will be awarded the assignment. Additional services are not included in the Municipal Health and Care Services Act. These services are not part of the contract. The user pays for these services themselves and it is voluntary for the user whether they want additional services or not. The payment and rates for additional services purchased from the supplier are a relationship between the service provider and the user. There are currently approx. 180 inhabitants in Malvik municipality who receive home help.
