The assignment shall support a structured and systematic learning process. The overall objective of the assignment is to support the implementation of the model through continual learning and to create an understanding of any change needs. The research shall contribute to concretising the goal achievement of the MTU and giving an independent assessment of whether this strengthens the police's ability to solve the social mission.
