The WPS is being implemented to automate and enhance production processes across the entire organisation, fulfilling these key functions: Resource Allocation and Scheduling: The WPS acts as the central engine for Provisioning by selecting required Resources (hardware or software endpoints) from defined Resource Pools based on the needs of a request. This includes providing an intelligent schedule capable of determining and flagging Clashes of resources, such as devices or rooms.
