Two Addendums have been published in relation to this Request for Tender. On 30th June 2026, Addendum No. 1 and a revised Request for Tender document (Request for Tender for Exhibition Design, Manufacture and Fit-Out Services for Donegal Famine Heritage Centre CLG Operating as 'The Workhouse', Rev 2.pdf) was uploaded to the tender workspace. This addendum (No. 1) outlines important clarifications, simplifications, and updates regarding the Mechanical and Electrical (M and E) scope of works and specific exhibition fit-out requirements. Specifically the addendum removed the requirement for an active humidity control system and clarified the number of heating units that needed to be upgraded (four legacy storage heaters needed to be replaced). The Display Case Specification has also been updated. The requirement has been updated from "conservation-grade" to "high-quality" display cases to reflect the nature of the exhibition assets. On 10th July 2026, Addendum No. 2 and a revised Request for Tender document (Rev 3), was published to the eTenders workspace. The addendum No. 2 critical technical clarifications and aligns the Request for Tender (now updated to Rev 3) with the project's key deliverables. The principal modifications and clarifications are as follows: Correction of "Artefacts" Terminology: The term "artefacts" has been formally replaced with "legacy models and exhibition items". The addendum clarifies that specialist, museum-grade conservation handling is not required, and the Contracting Authority will provide secure on-site storage during the renovation works. Digital Archive Explorer Clarifications: The technical specifications for the interactive kiosk have been updated to mandate a hybrid approach. Pre-digitised core historical assets must be stored and hosted locally on the kiosk for fast access. Additionally, the system must feature a secure, restricted external web browser ("Kiosk Mode") to allow locked-down access to specific external databases, such as the Donegal County Archives and the National Archives. Alignment of RFT Sections (Rev 3): The 'Key Outputs', 'Project Delivery Phases', and 'Award Criteria' sections have been comprehensively updated to explicitly define the required technical and design deliverables for immersive media. This includes formalising the requirements for short films, animations, projection mapping, creative set design, and the dedicated temporary exhibition space. Tenderers are instructed that all submissions and pricing schedules must be based strictly on these clarified requirements and the newly uploaded Rev 3 Request for Tender document.
