However, the current depot network in Dublin West is constrained and unable to accommodate these additional buses. As demand increases, expectations for continued growth and service reconfigurations place further pressure on the existing bus depot network, particularly as suburban population growth accelerates. The Ballycoolin depot will support this expansion by providing dedicated facilities for EV maintenance and charging while also providing onsite accommodation for operational and administrative staff.
