Deskrizzjoni: he design and construction of the flood defence works are subject to environmental controls addressing the sensitivity of the River Clodiagh, Inland Fisheries Ireland working windows, bird nesting season constraints on vegetation removal, invasive species and crayfish plague biosecurity, and the setting of the Rahan monastic complex. The Consultant is required to describe the environmental management measures to be applied to the commission, which are assessed as a suitability criterion, and to prepare a construction and operational stage water quality and fisheries protection method statement. The Scheme itself is a climate change adaptation measure, providing protection to the 1% AEP fluvial standard.
