Deskrizzjoni: Background and purpose Færder municipality plans to separate the old AF system to waste water and surface water as well as lay new water pipelines in the centre of Tjøme, stage 3. The work will include excavation work, rock drilling and renovation of the hose. The contract work is divided into two phases; an interaction phase first and then the execution phase. This contract includes all works with new water and sewage installations as shown on the attached drawings, as well as the re-establishment of affected roads. There shall be continual operation of the existing pipeline installations all days throughout the entire construction period. The pipeline route and manhole placement are in the plans that have been prepared. It is anticipated that the ditches will consist of both uncompacted trenches and rock trenches. The trench depth varies from 2.0 to 3.0 metres, with specific locations up to 5.5 metres. Deskrizzjoni: In accordance with the Supply Regulations § 7-9, climate and environmental considerations shall as a main rule be weighted with a minimum of thirty percent in the award criteria. Climate and environmental considerations as the award criteria can be replaced with climate and environmental requirements in the requirement specification, if it is clear that this gives a better climate and environmental effect, cf. FOF § 7-9 (4). This procurement is for construction work for clearing existing water and sewage pipelines in densely populated areas. The most important climate and environmental footprint will be related to excavation, material, mass handling and transport of matter, as well as waste management. The contracting authority estimates that the climate and environmental requirements in the requirement specifications will have a better effect in this procurement than safeguarding climate and environmental considerations through the award criteria. Based on the fact that there are relevant requirements that can be set in the requirement specifications for the climate footprint and environmental impacts that have been identified. By setting concrete requirements for products and systems, the contracting authority can be sure that the tenderer must implement measures to reduce the climate footprint and the environmental impact of the contract work. In a competition where climate and the environment are included as an award criterion, a tenderer who delivers the worst on this criteria can still win the competition. Climate and environmental requirements have been set to limit climate and environmental impact, including: - An electric lorry shall be used for transport to and from temporary warehouses. - Excavators shall as a minimum be emission class Step V, other vehicles Euro VI. - Requirements for the preparation of a logistics plan to i.a. reduce emptying - Requirements for reuse of matter. - Requirements for handling foreign species. - Waste management requirements at the site. - Revegetation requirements. - Requirement to use low temperature asphalt - Requirements for measures to prevent the spreading of plastic waste - Tenderers are required to have an environmental management system that ensures that the tenderer works systematically internally in their activities in order to reduce the environmental impact.
