The framework agreement will also include fresh cakes/confectionery products for all orders that require delivery at weekends. The framework agreement will be valid for 2 years, with an option for the contracting authority to extend the contract for 1+1 year. A contract shall be signed with one tenderer. A comprehensive description of the delivery is in the annexes to the tender documentation.
