2.1. Proċedura

Titlu: Agreement for the execution of various topographical tasks

Deskrizzjoni: 5-year agreement for the execution of various topographical tasks involving the Fluxys' pipeline network. Fluxys constructs, manages and operates an infrastructure for high-pressure gas transmission by pipeline in Belgium. Actually, this network is about 4 200 km long. The technical and administrative data for this network are given in a database which is used by various departments in the company. This database — which is spatial — plays a key role in the operation of the pipeline network. This means that a lot of importance is attached to the accuracy of the data. The 3-dimensional aspect of the database is mainly the result of topographical surveys. Fluxys mainly uses external surveyors to conduct these surveys. The tasks involving new and/or existing Fluxys' pipelines and substations may include: (a) terrestrial site survey and mapping of new and/or changed topography; (b) terrestrial site survey and mapping of new and/or changed topography vis-à-vis the existing topography; (c) terrestrial site survey and mapping of a new site profile; (d) terrestrial pipeline survey + accessories and mapping of a new pipeline profile; (e) digital output — supplying files in all of the following formats: Microsoft Excel format, Microstation DGN format and the Fluxys' exchange format XSUF. As well as to take note of a ETL-application (Extract, Transform en Load) such as FME (Feature Manipulation Engine); (f) the use of other surveying techniques alongside topographical surveying, e.g. active radio detection and ground tracing; (g) tasks involving the preparation for site levelling; (h) the tasks involving the purchase and sale of Fluxys sites include the preparation of survey and/or demarcation reports.

10. Requested information about each above-mentioned selection criterium. Legal form to be taken by the group of economic operators to whom the contract is to be awarded: 1. Tenders or requests to participate may be submitted by a group of economic operators who will not be required to adopt a particular legal form prior to the award of the contract. A letter of consent between the members of the group should be included in the request to participate and all the information required under the contract notice should be provided for each member of the group. In the case of a joint tender, all members of the group assume joint and several liability towards Fluxys for the performance of the contract as a whole, i.e. both financial and operational liability. The operators forming a group must designate one of them as a single point of contact (SPOC) towards Fluxys for the administrative, financial and operational management of the contract. Furthermore, the operators forming a group should provide information on the role of each member of the group. After the award, Fluxys will sign the contract either with all members of the group, or with the SPOC on behalf of all members of the group, authorized by the other members via powers of attorney. 2. In order to prove its economic, financial, technical or professional capacity, an economic operator may rely on the capacity of other entities, whatever the legal nature of the link between itself and those entities. The economic operator must prove to Fluxys that the necessary resources will be available to it, by delivering a written undertaking by the other entity to that effect.

Deskrizzjoni tal-kriterju ta' selezzjoni: The candidate must have the necessary economic and financial standing to perform the contract. Proof of the candidate's economic and financial standing may be furnished by one or more of the following references: - the presentation of financial statements or extracts from the financial statements, where publication of financial statements is required under the law of the country in which the economic operator is established; - a statement of the economic operator's overall turnover of the last three financial years available, depending on the date on which the undertaking was set up or the economic operator started trading. This criterion applies to the candidate as a whole, i.e. through the combined capacity of all members of the group in case of a group of economic operators.

In the event the economic operator does not meet the aforementioned ratio's and /or the economic operator is not able to provide a parent company guarantee of any other entity pursuant to 5.1.6, it shall provide, latest with Final Offer, an unconditional, irrevocable and first demand bank guarantee as per Belgian law in the amount of 5% of the total value of the contract for each of the conditions breached, guaranteeing the performance by the economic operator of its obligations arising out of this Contract Notice (if the contract were not to be awarded to the economic operator; such bond will be ended during Stand Still period).

Deskrizzjoni tal-kriterju ta' selezzjoni: The candidate must demonstrate that he: — is conversant with terrestrial topographic and ground-level surveys; — has experience of terrestrial surveys in a cable and/or pipeline construction context; — is conversant with or can become conversant with supplying topographical, ground-level and pipeline files using various exchange formats (Microsoft Excel, CAD Bentley Microstation DGN and Fluxys XSUF/XML formats); — is registered in the Surveying Expert list (Federal Council of Surveying Experts) with knowledge of the Belgian legislation concerning property law, property rights, etc., or have at least 1 representative under contract for this purpose, with regard to preparing survey and/or demarcation reports for Fluxys sites; — is conversant with or can become conversant with various surveying techniques, e.g. active radio detection and ground tracing; — is compatible with the standard CAD systems; — is conversant with project management (aspects: planning, financial and technical management, etc.).
