Contracts will be awarded off the framework by means of mini-competitions among the appointed framework members. The award criteria for mini-competitions will be detailed in the tender documents issued at the time of each call-off. The initial contract under this framework will involve the delivery of public lighting works across Dublin City, including installation, maintenance, and associated civil and electrical works, in compliance with Dublin City Council standards and specifications. The works will include, but are not limited to:

- Supply and installation of ducting, cable chambers, public lighting columns, and PL mini-pillars
- Replacement of existing columns in situ, including associated traffic management works
- Stripping down and removal of columns
- Ground opening for ESB works and reinstatement of ground
- Pulling cables into ducts, glanding and terminating cables
- Installation of brackets and lanterns
- Renewal of public lighting overhead cabling
