Elementi prinċipali tal-proċedura: In addition to individual journeys in service, NRK also needs coordination of journeys for small and large groups of varying lengths and scope for units in NRK within administration/staff, sports, drama, news and entertainment. An important part of the travel agency's service will therefore be to help NRK with the most efficient planning, booking, coordination and execution of this travel business. The safety aspect is very important for NRK, and NRK's travel agency shall therefore have routines for unsolicited to provide information on where employees on official journeys are at all times, and actively be able to assist the individual and NRK if unfortunate incidents occur. As a result of NRK defining the contract as a service contract, it is a condition that a fixed price agreement will form the basis for calculating compensation for ordinary travel agency services for individual journeys, and not service fees per assignment etc. For courses, conferences and complicated group journeys, the travel agency can still calculate fees per assignment.
