The project also includes Statskog SF's areas, which make up approx. 8% of the area. Forests in protected areas shall not be assessed. The valuation shall be carried out in accordance with the "Regulation on grants for forestry planning with environmental registrations". The valuation is included in the government manager's main plan for forestry planning. The valuation is included in the Administrator's main plan for forestry planning. The valuation project has already been granted a partial award of nok 2.8 million from the government manager for the main project. The contracting authority shall apply to the government administrator for certification so that the project can be subsidy justified. The assignment is announced as an open tender contest without negotiations.
