The estimated value for the contract period (including the option years) is approx. NOK 5-6.2 million (excluding VAT). procurements and future budgets. and is not binding for the contracting authority, but it shall only be seen as a guideline. The volume can vary and will depend on, among other things, the contracting authority's needs, activities, budgetary situation, political decisions and other framework factors.
