Beschrijving: According to the Supply Regulations § 7-9 (2), the Contracting Authority shall emphasise climate and environment considerations with a minimum of 30% in the award criteria. There is, however, an opportunity to depart from this main rule if it is "clear that" the climate and environmental requirements in the requirement specifications provide a better climate and environmental effect, and this is justified in the procurement documents, cf. the utilities regulation § 7-9 (4) first period. There are minimum requirements in this procurement in accordance with Oslo municipality's standard climate and environmental requirements, including requirements for emission free construction sites and requirements for fuel technology for other transport. These are in the tender documentation annex 2 contract formula NS 8405 point 22. It is clear that these requirements give a better climate and environmental effect than weighting climate and environmental considerations with a minimum of 30% in the award criteria. I.a. due to conditions stated in the following. The machines where there are no requirements that shall carry out the work emission free, shall use a minimum of euro class 6/VI and documented sustainable biofuels beyond the turnover requirements. The lower threshold is biogas by transporting matter respectively and by other transport by vehicles

under 3.5 tons. Other transport by vehicles over 3.5 tonnes, as a minimum, it is to use fossil free vehicles for transport that as a minimum fulfil euro class 6/VI. Bio-fuel used in the implementation of the contract shall be documented sustainable biofuels beyond the turnover requirements. By 1.1.2027, all vehicles used in the implementation of the contract must be emission free or biogas based. However, VAV would like to award tenderers who can offer climate-friendly solutions beyond the minimum requirements, and will therefore weight climate or environmental considerations by 10%. This represents an overfilling of the procurement regulations' requirements for taking care of climate and environmental effects.
