Titel: Procurement of security guard services Stavanger

A security guard is also required to go through the buildings in the evening /night. The contracting authority draws attention to the fact that the security guards who shall carry out the services must be security cleared for the CONFIDENTIAL level. A site inspection will be held with all tenderers Wednesday 24 June, 12:00 at Kartverket, Stavanger. Delivery of classified requirements and signing of a security contract. Tenderers can provide up to 2 persons for the site inspection.
