Beschrijving: This procurement is for handling storage and logistics of library material, consisting of storing books as well as manual handling in the form of receipt, registration, picking, packing and preparing for lending and returning. Transport is not a part of the procurement and is handled through a separate contract. The climate and environmental impact of this procurement is mainly related to the continual operation of storage and energy use in storage buildings, internal logistics handling and waste handling. The market analysis shows that there are few tenderers in the market for this type of specialised services. Tenderers say that energy efficient operation and good waste management have already been established, and the use of climate and environment as the award criteria is therefore assessed to have a limited effect. Packaging is drawn as a relevant environmental measure. The contracting authority has assessed reusable plastic boxes, but experience shows that these are often lost or used for other purposes, which reduces the climate effect. The system is therefore assessed to give uncertain environmental gains in this procurement. The market is considered as mature for emission free aids in internal logistics, such as electric forklifts. The

contracting authority has therefore concluded that the following environmental measures are best taken care of through minimum requirements rather than award criteria: · Energy efficient operation of storage and activity. · The use of emission free forklifts and other relevant logistical equipment. · Source sorting and environmentally responsible waste management. As these measures are already widespread in the market, minimum requirements are assessed to provide greater and more predictable environmental effect than the use of award criteria. For this reason, the contracting authority has concluded that it is not appropriate to weight climate and environmental considerations by 30 percent, because it is not expected to provide real or measurable environmental gains. Setting contract requirements and minimum requirements for energy efficient operation and waste management in this procurement will give a better climate and environmental effect.
