Opis: PURPOSE AND SCOPE The Agency for Education is responsible for the design, execution and return of municipal tests, Oslo tests, in different disciplines/skills at a selection stage in primary and secondary schools. As part of the work on design, quality assurance, implementation and return of results from the Oslo tests, the Agency for Education wants to enter into an agreement with a professional environment that will be responsible for the subject area "maths/mathematics" from the school year 2026/2027 until the end of the school year 2028/2029 with an option for up to two years. Background The Agency for Education (UDE) has a trial and follow-up plan that is included in a comprehensive work for on-the-go assessment and follow-up of the Students in Oslo. The plan is a part of UDE's system for following up requirements in the law and regulations, including the national quality assessments. The aim of the system is to contribute to quality development in primary and secondary education and increased learning outcomes for the pupils. In addition to regular underway evaluations in the class room, tests and mappings provide useful information on the pupils' competence and areas of development. This information shall be actively used by pupils, teachers and school managers to promote learning and ensure early efforts. The trial and follow-up plan includes both governmental tests (government mapping samples and national tests) and municipal tests (Oslo samples). Math/mathematics does this apply to Oslo tests in mathematics for pupils at Sixth Form College and Oslo maths as basic skills for pupils in primary and lower secondary schools. These are implemented electronically and re-developed each year.
