Tenders can be submitted for one or more locations that fulfil the requirements in the tender documentation. Each offered 24 hour resting place will be assessed as an independent tender. The contracting authority shall have a maximum of 24 hour resting place per municipality. A maximum of one contract will therefore be awarded for 24 hour resting places per municipality.
