The estimated value of the procurement is estimated to NOK 20,000,000 - NOK 25,000,000. The Norwegian Environment Agency's budget limit for the monitoring programme is NOK 2,300,000 per annum. The budget limit in 2026 is NOK 3,600,000 due to an increased budget limit.
