The procurement's value is estimated to: NOK 70,000,000 excluding VAT. The maximum value for the entire contract period, including any options and expected price rise: NOK 100,000,000 excluding VAT. The need is uncertain. The volume can vary both up and down and the contract period will depend on, among other things, the contracting authority's needs, activities, budgetary situations and other framework factors. The ordering of the vehicle(s) will be made individually by each company. See the price form and the needs description for further information. The Public Procurement Regulations § 7-9, the fourth section will be used in this procurement. The main performance of the procurement is vehicles, of which the largest environmental impact is in possible emissions resulting from fossil fuel. In this procurement, vehicles with biogas based operations shall be procured.
