The rating shall be based on the last known accounting figures and it shall be carried out by a credit information company with a licence to conduct this service. Recently established companies with an credit rating, some foreign companies or companies without reporting obligation to the Brønnøysund Register Centre will not always be able to provide a credit rating as documentation that the qualification requirement is fulfilled. In such cases this can be compensated with other suitable documentation.
