Stage 1 of the project included the establishment of an submarine pipeline from Gjøvik to Redalen, the construction of a pressure increase station, as well as establishing a connection point for continuing the pipeline towards Biri. The sea pipeline was lowered in Mjøsa in autumn 2020, and after completion of the pump station the facility was put into operation in 2021. In stage 2 the pipeline shall be continued from Redalen to Biri, where both a raw water pump station and a new water treatment plant shall be established.
