The aim of the procurement is to cover the contracting authority's need to get a better overview of the road's condition by using friction measurement. Such information can provide us with documentation of when maintenance measures ought to be initiated. In addition it is an important tool to be able to assess whether the measures have the correct effect and that established standards are followed.
