NESAs has begun a project for establishing a modular performance for undersea cable work and repair performance to be used in Baltic Sea to enable performance to repair and maintain subsea cables in the Baltic and Bothnic region using stateowned equipment. NESAs is establishing a joint consortium with main participants; Post- och telestyrelsen, Sweden and Elering AS, Estonia.
