Descriere: The Client seeks the execution of the Works described below to improve the transport and operational conditions of a section of the public road of national importance M-06 Kyiv-Chop, (to Budapest passing through Lviv, Mukachevo and Uzhhorod) km 546+437, Lviv Region. The objective of the Project is to enhance transport and operational conditions of the road. To achieve this, the Client intends to construct a new overpass at the intersection with the railway and an underground pedestrian crossing. The Project will upgrade the technical parameters of the designed road section and overpass from category II to category I-b, thereby improving road safety and supporting climate adaptation goals. The construction of an underground pedestrian crossing at km 547+250.00 is expected to significantly enhance pedestrian safety. At the same time, the existing overpass at the railway intersection will be dismantled.

The road section from km 546+347 to km 548+278 (1.931 km) is designed according to the parameters of category I-b, and on other sections the transition to the parameters of technical category II is being made. The axis of the route on the projected road section is laid with maximum use of the existing right-of-way. The beginning of the route was taken along the road axis at PC 5462+97 and corresponds to operational km 546+297, the end of the route was taken at PC 5483+91 and corresponds to operational km 548+391. The total length of the road section to be constructed is 2.094 km. From PK 5469+83 to PK 5482+25 (1.242 km) the road passes within the settlement of Pasiky-Zubrytski. In accordance with the task and traffic intensity calculations, the main technical standards adopted for the design are: - road category - I-b; - design speed - 110 km/h (outside settlements); - design speed - 60 km/h (within settlements); - number of traffic lanes - 4; - traffic lane width - 3.75 m; - width of the fortified lane - 0.5 m; - the width of the stopping lane together with the fortified lane - 3.0 m; - shoulder width - 3.75 m; - width of the dividing lane - 3.0 m. The qualification criteria for the period of January 2020 - December 2024. Financial Situation: 1.
