The contract with Telenor expires in 2026 and the procurement is therefore re-announced. Norsk Tipping shall continue to have a minimum of two independent suppliers with independent infrastructure. Telenor's lines and infrastructure will be subject to competitive tendering in this competition. This means that the agreement with Telia/Eidsiva Digital is planned for competitive tendering in 2027. Norsk Tipping AS (AS202230) currently has the status of LIR (Local Internet Registry) and has its own official IP addresses for both IPv4 and IPv6. The primary need is for the delivery of internet transit with close to 100% uptime, with two accesses in two conducive paths and capacity of up to 100 Gbps per access. Flexibility connected to capacity needs and full control of the entire delivery chain – especially in the backbone – is a central requirement.
