The majority of the courses will be delivered indoors in a classroom environment however some outdoor space may be required for demonstration/ role play purposes, 'live' ammunition will not be used for this. Therefore, the venue must also have suitable outside space available which is away from the general public so as not to cause disturbance (this will be for occasions when there is no availability at The Lifewise Centre). The venue must also provide free onsite parking.

Courses are booked up to 12 months in advance but can be cancelled at short notice, however, numbers are typically confirmed one month in advance. Accommodation facilities will be required as these courses attract officers from all over the UK who could require accommodation; refreshments and lunch must also be provided by the venue.
