The framework agreement period is 4 years and the estimated value is NOK 60 million. The contracting authority requires a prioritised customer and that work as needed shall start within 48 hours on weekdays. The tender deadline is shortened to 10 days by use of a prior information notice in accordance with the procurement regulations (FOA) § 20-3 fourth paragraph.
