There can be a need for services connected to transport, as well as packing, loading, unloading and any temporary storage. Collection transport can include collections up to several hundred years old and of great historical value. The collections can consist of books, manuscripts, maps, periodicals, various film and audio formats, photographic materials, broadcasting materials, hard drives, and other materials owned by the National Library of Norway or its owning external collaborating partners. Transport of assemblies requires high security from dispatch to reception. When transporting to and from abroad, the transporter must ensure customs processing in accordance with the current rules for cultural objects. Relevant shipping methods can be packages/boxes, plastic boxes, whole and half pallets, or entire semi-trailers on 33 whole pallets.
