Glavne značilnosti postopka: The platform (main area 1) shall form the core of the municipalities' digital health and care services and ensure that all relevant health technological systems can be integrated in a seamless, secure and user friendly way. The regional, common welfare technological platform must be operative by 1 September 2026. The contract will be signed by all the municipalities in the Lofoten ICT cooperation for the procurement/hire of equipment for persons living at home (cf. the main area 2) as well as an option for equipment for an institution and manned residence (cf. main area 3), this shall be regulated through a separate framework agreement (SSA-R + SSA-K) with two sub areas, where each municipality is given the right to make call-offs and possibly utilise options. Tenderers are requested to note that options in accordance with point 3 presuppose a prior competition for upgrading the ICT infrastructure in each municipality. Upgrading of the ICT infrastructure is, for these reasons, not included as a separate point in this procurement. Obrazložitev trajanja okvirnega sporazuma: The maximum duration of the framework agreement is determined to be six (6) years, based on a combined assessment of the market situation and the economic and technical prerequisites for the delivery. The contracting authority has documented through a market dialogue that the tenderer's business models are so adapted that it is not commercially appropriate to switch equipment suppliers without switching the accompanying platform system. The delivery requires considerable investments, both in platform technology and the accompanying equipment. A supplier change across equipment and platform will incur disproportionately high costs connected to the change of equipment and/or establishment, integrations and any other transition costs. It is, therefore, scheduled to assess the supplier's replacement costs connected to the municipalities' existing equipment in the procurement. While technically it is possible to establish APIs or other integrations towards alternative solutions, the contracting authority's understanding will typically be growing and it will not represent a commercial or socio-economically effective approach. Based on this, a framework agreement will be assessed with a duration of six years as necessary and proportionate in order to ensure sufficient competition, cost efficiency and predictability in the delivery.
