The project is based on four key pillars, being 1. judicial efficiency, 2. judicial independence and accountability, 3. quality of justice and legal education and 4. transparency and access to justice. These four pillars work as a very integrated part of each other, however each aiming to target the most challenging issues identified during the implementation of the reform, as much as consolidate best EU practices already developed by EU4Justice I.
