The bottom box, a residue product of the incineration process, contains magnetic and non-magnetic metals that can be recycled.

Bunnasken from Haraldrud Energy Recovery Plant is not defined as hazardous waste. This is production waste that is transported and processed before a final landfill. The bottom ash must be transported from the plant in containers, pre-treated/sorted before a residue fraction of the ash is finally deposited. The agreement shall include transport of bottom ash, including container hire, recycling of metals and depositing residual bottom ash.
