Mould-infected documents that are granted barracks shall be transported for burning. Tenders shall include emptying (packing, packaging and transport), media conversion and casing (transport and burner) with the accompanying services, such as clearing of means of transport, packaging boxes etc. The final result shall be an empty basement archive and the content is archived in accordance with the current rules.
