Signing of a contract over a period of two years means that the shipowner is obliged to provide the vessel for this expedition in the stated period and at the relevant time. The vessel must have a minimum 15 tonne annual quota for blue whiting. The annual expedition shall take place for approx. 16 days within the period from 10 March to 10 April.
