The Contracting Authority reserves the right to waive the Pre-Financing Guarantee requirements, if the Contractor does not require the advance payment for the works. In this case, the Contractor bears responsibility to implement the contract using their own means. A 100% payment will be made to the contractor by the Contracting Authority upon the delivery and provisional acceptance of the goods. For a minor contract ($\leq$ NOK 200 000), the Contracting Authority, depending on its assessment of the risks, may decide to waive the Performance Guarantee requirement.
