The contract period is eight years, with an estimated total contract value of NOK 130 million excluding VAT and a maximum limit of NOK 160 million excluding VAT. The contract has comprehensive requirements for seriousness, HSE, environment and use of emission free or biogas based vehicles and machines where possible.
