Two types of equipment shall be procured for the purpose of preventing unwanted monitoring and monitoring. The contract includes: • Lot 1: Equipment to prevent audio recordings by blocking or interfering with microphone functionality. • Sub-contract 2: Equipment for screening or screening electronic signals that shall prevent tracking and electronic communication. This includes service, maintenance, repairs and any replacement of equipment, so that the functionality and security level are maintained over time. The maximum roof is set at NOK 5 million.
